


2019 NUMBERS AT A GLANCE

- 44,032,500: Approximate number of immigrants¹ living in the U.S. (14% of the population)
- 4,432,100: Approximate number of immigrants in New York (23% of the state's population)
- 12,200: Approximate number of immigrants in Saratoga County (5% of the county's population)
- 53%: Estimated increase in the number of immigrants in Saratoga County in the past 10 years.

Distribution of Immigrants

Figure 1 shows where immigrants live in the state of New York. The counties of Queens (47%), Kings (36%), and the Bronx (35%) reported the highest percentages of immigrants. Hamilton County (1.7%), Chenango County (1.6%), and Lewis County (1.6%) reported the lowest percentages of immigrants.

Figure 2 shows that 45 percent of the foreign born in Saratoga County and 57 percent of all other immigrants in New York state arrived in the United States before the year 2000.

Additionally, the median year of arrival for foreign-born individuals in Saratoga County is 2001 and the median year of arrival for all other immigrants in New York state is 1997.

¹Please note that the terms "immigrant" and "foreign born" are used interchangeably throughout this fact sheet. Foreign born refers to individuals who are not a U.S. citizen at birth or who were born outside the U.S., Puerto Rico or other U.S. territories and whose parents are not U.S. citizens. The foreign born may include naturalized U.S. citizens, Legal Permanent Residents, temporary residents, refugees and asylees, and others. Additionally, native born includes those who are U.S. citizens at birth, those born in the United States, Puerto Rico, or other U.S. territories, and those born abroad to a parent who is a U.S. citizen.





English Proficiency

Figure 3 shows that immigrants in Saratoga County are more likely to be proficient in English compared to all other immigrants in New York state. For example, nearly three-fourths (74 percent) of immigrants in Saratoga County are proficient in English. This is significantly higher compared to all other immigrants in New York state (54 percent).



Country of Birth

Figure 4 shows that 15 percent of immigrants in Saratoga County came from Canada, the United Kingdom, or the USSR/Russia, countries which are not in the top five for the rest of the state. Also, none of the top five countries of origin among immigrants living in Saratoga County are from Latin American countries, which is quite distinct from the rest of the state. For example, 20 percent of all other immigrants in New York state were born in either the Dominican Republic, Mexico, or Ecuador.

Household Income

Figure 5 shows that compared to all other immigrant-headed households in New York state, immigrant-headed households in Saratoga County are more likely to earn \$75,000 or more and have higher median household incomes. For example, 71 percent of immigrant-headed households in Saratoga County earn \$75,000 or above. This is significantly higher compared to all other immigrants in the state of New York (39 percent). Additionally, the median household income of immigrant-headed households in Saratoga County is more than double the median household income of immigrant-headed households in the state of New York (\$114,436, vs. \$55,142).

Industry

Figure 6 shows that overall, immigrant-headed households in Saratoga County are employed in significantly different industries compared to all other immigrant-headed households in New York. For example, compared to all other immigrant household heads in New York state, immigrant-headed households in Saratoga County are more likely to work in manufacturing and professional, scientific, and technical services industries and less likely to be employed in the following industries: health care and social assistance, accommodation and food services, transportation and warehousing, construction, and retail trade.

A household includes all the people who occupy a housing unit. A native-born U.S. citizen household is defined as a household which is headed by a native-born U.S. citizen, regardless of the immigration status of the spouse. Conversely, an immigrant headed household is defined as a household which is headed by a foreign-born individual, regardless of the immigration status of the spouse. With regard to income, the total family income is used. This includes the total annual income of all family members in the household.
