# **Course Description**

This course provides practical work experience via an internship, service-learning project, consultancy, or field study that the student brokers with a third party. The purpose of experiential learning is to seek new challenges and experiences and to apply classroom learning to real-world problems and projects.

# **Student Learning Outcomes**

Skills developed through this course include written and oral communication, critical thinking, research, leadership, and project management. The course content, readings, class activities, assignments, and emphasis on applying theories and concepts to practice (reflective practice) are intended to contribute to student learning and development of these competencies.

# **Course Objectives**

Consider:

i.Cognitive Objectives: What students should know

ii. Affective Objectives: What students should care about, or how they perspectives will be

iii. Behavioural Objectives: What students should be able to do?

Examples from previous experiential learnings:

- Research on potential grantors and funding/fundraising from a variety of funding streams, including an assessment of their efficacy.
- Gain experience with non-profit event preparation and grant fund management
- Learn how outdoor education can contribute to more sustainability-minded youth
- Network with environmental professionals
- Identify extent to which current non-project management curricula identify these issues
- Contribute recommendations to curricula changes to fill gaps
- Monitor the types of organizations being partnered with and the content of the data being collected to see what Jewish individuals, communities and voices may be missing
- Drafting two social media posts per week to help spread the word about the collection project to additional American Jewish institutions and individuals
- Improve knowledge on local and state-wide social and economic services
- Understand how social media can become a strategy that improves the marketability of the organization

This portfolio will include tangible documentation of your progress in researching non-profit start up options, strategies, etc. as well as actions in line with startup establishment (if applicable). - Research on establishing non-profit name, mission, vision, business plan, bylaws.
- Research on the problem of homelessness in the DC area.
- Research on potential partners (homeless shelters/outreach groups).
- Research on requirements for 501c status and any additional research that filing would require.

## 2. Assignment #2 (### possible points | ##% of course grade)

During the EL, you will keep a journal and submit it to me as required by the course schedule. My hope is that the journal will serve as a tool for reflection as we engage in readings, activities, etc. I encourage you to use the journal as a place to think out loud about your project, issues you are considering, dilemmas and scenarios you are mulling, challenges you are working, etc. I will post questions for you to discuss in your journals.
