# INTRODUCTION TO HOMELAND SECURITY

#### **Enrollment**

This class will examine the history and creation of the Department of Homeland Security as well as fundamental concepts of homeland security. Students will examine the events leading up to September 11<sup>th</sup> and the events that followed to secure and protect America. We will explore the shift in policy from one Administration and how government's efforts have changed since the 9/11 attacks. The class will explore all aspects of homeland security to include natural hazards, man-made hazards and terrorism. Emphasis will be on understanding the entire framework of homeland security in the United States. This class will be unique in that much has recently changed and will continue to change based upon the policies made by a new Administration DHS, and Congress. We will examine how the previous Administration made structural changes to DHS and changes in policies dealing with homeland security, response, recovery, hazards, intelligence and immigration. We will explore these topics and the challenges presented to the incoming Administration as well as how Covid-19 impacts what DHS has attempted to recently undertake.

#### **Course Format**

Class sessions will consist of lectures, class discussions, and student presentations. This course will have an informal atmosphere seeking to engage students in discussion to draw out the teaching points. Students are expected to arrive on time and be prepared to discuss the assigned readings and to contribute to an atmosphere of identifying, exploring, and solving real issues. During the semester we will have a number of guest speakers. This is a learning environment and at times there will be different opinions on topics. Civility, respect and professionalism are required of all students. Students must adhere to the guidelines of the GMU Honor Code.

# **Class Participation**

Each **Thursday** students will type a summary on a news article/current event dealing with a Homeland Security topic that is in the news. (Double Spaced just giving pertinent facts-No more than one page) Students will be called upon to discuss their current event article. There are a total of ten current event articles.

#### **Papers**

Students will **choose from a list of approved topics for the paper a topic and submit topic for approval**. (10 pages double spaced, Times New Roman). Examples of topics may include a group profile on a terrorist group, Natural Hazards and DHS Response, case study of a terrorist attack, Homeland Security after 9/11, Costs of Homeland Security, FEMA Failure or Success After Hurricanes, 9/11 Commission Summary, Role of FEMA, Evolution of Homeland Security, FBI Stings Another Terrorist, Critique of the DHS, Immigration on the Border, Trump's Border Wars, Role of the Patriot Act, Intelligence Comm unity Since 9/11, Lone Wolves in America, (Have a Draft of Paper and have someone else read it or take it to the Writing Center). Paper should be of a publishable quality. **Paper Due on March 28, 2024.**
