

2020 NUMBERS AT A GLANCE

Distribution of Immigrants

The top three counties with the highest percentage of foreign-born residents are located in northeastern Illinois and include Cook (21%), Dupage (19%), and Lake Counties (19%). These three counties are all located within the bounds of the Chicago metropolitan area, which has been a traditionally popular immigrant destination for international immigrants. Notably, Cook County includes the city of Chicago, a city with a particularly rich history of immigration since the late 19th century. By contrast, the counties with the lowest share of immigrants are Alexander (.27%), Gallatin (.28%), and Greene Counties (.32%), three small counties in rural areas with few pull factors for immigrants.

All analysis in this fact sheet is based on source data from the U.S. Census Bureau American Community Survey, 2016-2020 distributed through IPUMS-USA, University of Minnesota, www.ipums.org, unless otherwise noted.

Please note that the terms "immigrant" and "foreign born" are used interchangeably throughout this fact sheet. Foreign born refers to individuals who are not a U.S. citizen at birth or who were born outside the U.S., Puerto Rico or other U.S. territories and whose parents are not U.S. citizens. The foreign born may include naturalized U.S. citizens, Legal Permanent Residents, temporary residents, refugees and asylees, and others. Additionally, native born includes those who are U.S. citizens at birth, those born in the United States, Puerto Rico, or other U.S. territories, and those born abroad to a parent who is a U.S. citizen.

Figure 2 shows that immigrants in Peoria County, IL immigrated to the United States more recently than all other immigrants in Illinois. For instance, more than 3 in 5 (62%) immigrants in Peoria County arrived in 2000 or later, compared with 43% of immigrants elsewhere in Illinois. In the 20th century, only around a third (38%) of immigrants in Peoria County arrived to the U.S. between 1930 and 1999, compared with 57% of all other immigrants in the state. The median year of immigration, which is 2004 for immigrants in Peoria County and 1997 for all other immigrants in Illinois, further underscores the trend of Peoria County immigrants being more recent arrivals to the United States than their counterparts. This trend makes sense considering that Peoria County is a new and emerging immigrant destination that draws high-skilled immigrant workers to computer, engineering, and science occupations. Such immigrant workers are more than three times as likely to be employed in computer, engineering, and science occupations (32%) in Peoria County than in the rest of the state (9%). Additionally, immigrants who arrived to the County after 2000, are four times more likely to be employed in computer, engineering, and science occupations (11%). Given these trends in occupation, it is not surprising that 59% of immigrants in the County have a bachelor's degree or higher, compared with only 34% of all other immigrants in Illinois, individuals who are most likely to be employed in service occupations (21%) that require lower formal education credentials.

Age 5+




Figure 3 shows that immigrants in Peoria County are considerably more likely to be proficient English speakers (70%) than immigrants in the rest of the state (52%). Immigrants' English proficiency is affected by many factors, including education, age at arrival to the U.S., and the opportunities immigrants have to speak English. Compared to immigrants in other parts of Illinois, immigrants in Peoria County have higher levels of educational attainment, while the most recent cohort of immigrants (i.e., immigrated between 2010-2018) are more than twice as likely to be 15 or younger (28%) than all other immigrants in the state (13%). Additionally, immigrants in Peoria County are more likely speak English at home (19%), compared to all other immigrants living in Illinois (12%).

Immigrants in Peoria County are about three times more likely to be from India (30%) than all other immigrants in the state (9%). One factor that partially explains this trend is the County's large share of computer, science, and engineering workers (32%), 60% of whom are from India. On the contrary, immigrants in the County are three times less likely to be from Mexico (12%), than immigrants elsewhere in Illinois (36%). A partial explanation for this pattern is that other parts of the state attract a higher share of immigrants working in service occupations (21% to 15%), over half (51%) of whom are from Mexico, compared to less than a third (32%) in the County. The other three top countries of birth for immigrants in Peoria County include China (5%), Vietnam (5%), and the Philippines (5%), with Vietnam being the only one that does not fall among the top five countries of birth for all other immigrants in the state.

Figure 5 shows that immigrant headed households in Peoria County are more likely to earn \$75,000 or greater (56%) than immigrants elsewhere in Illinois (43%). The median household income is \$85,559 for immigrants in Peoria County and only \$65,942 for immigrants elsewhere in the state. The County's highly-educated-and-skilled immigrant workforce may account for much of these differences in household income earnings.





Immigrants in Peoria County have nearly identical employment and unemployment rates compared to immigrants in other parts of Illinois, although immigrants in Peoria County are slightly more likely to be unemployed (5%) than their counterparts (4%).

For factsheets that examine populations at the household level, please note that a household includes all the people who occupy a housing unit. A native-born U.S. citizen household is defined as a household which is headed by a native-born U.S. citizen, regardless of the immigration status of the spouse. Conversely, an immigrant-headed household is defined as a household which is headed by a foreign-born individual, regardless of the immigration status of the spouse. For fact sheets that examine total household income, please note that the total annual income of all members in the household is included in the analysis. For fact sheets that examine personal income, personal income refers to total personal income earned on an annual basis.

For fact sheets that examine poverty status, please note that it excludes individuals who live in group quarters and those who are under the age of 18 with no family.
