FERPA@Mason: Student Rights under FERPA

The Family Educational Rights and Privacy Act of 1974 (FERPA) is a federal law that governs the education records of eligible students. It grants students continuous access to their education records upon request, allows students to amend their records if they feel they're inaccurate, and restricts how and when their education records can be disclosed.

When a student turns 18, or attends a postsecondary institution, FERPA rights belong to the student, not the parent.

Mason does not release non-directory information unless a student has provided consent, the release is to the parent of a dependent student, as required by § 23.1-1303.B.5 of the Code of Virginia, or the disclosure meets a qualified exception under FERPA.

Annual Notification of Rights under FERPA

The Family Educational Rights and Privacy Act of 1974 (FERPA) is a federal law that protects student privacy. Under FERPA, eligible students are granted certain rights with regards to education records:

- 1. The right to inspect and review their education records within 45 days of the request
- 2. The right to request amendment of education records if the student believes they are inaccurate
- 3. The right to require George Mason University to obtain written consent to disclose personally identifiable information from the student's education records unless an exception applies
- 4. The right to file a complaint concerning alleged FERPA violations with the Family Policy Compliance Office within the U.S. Department of Education

Students may give written consent to release their protected educational records to a third party by completing a <u>Consent to Release Student Information Form</u> and submitting it to the Office of the University Registrar. Students can rescind their consent at any time, which will prevent the release of that information from that point going forward.

GMU Email

Your GMU email account is the primary way George Mason University will send and request information from you. You are held responsible for all information sent to your GMU email account. Students who do not read their email on a daily basis miss critical information about their classes, academic advising, financial aid, registration, holds on student accounts, disciplinary action, deadlines, scholarships, internships, graduation, and more.

When communicating with GMU faculty and staff, send an email from your GMU account using the format below. Most faculty and staff get hundreds of emails each week, so if you want a timely response make your email brief and clear. The format for an email is different than for a text, and should include the following parts:

- Subject line so the recipient can quickly see what the email is about.
- **Greeting** this is a formality that most people still expect. The recipient may consider you rude or not understand who you intend the email for if you don't use a greeting. If you are not sure how to address a faculty or staff member (Prof./Dr./Ms./Mr.), look at your syllabus or Google the person (search "GMU Samantha Smith" and find a biography).
- **Brief message** briefly and clearly state what you expect from the recipient. The longer your email is, the more likely the recipient is to ignore it.
- **Signature** Make sure to conclude your email with your <u>first and last name and G number</u>. If you don't include this information, the faculty/staff you send the email to <u>will not know who you are and will not be able to help you</u>.

Guide for Students with GPA Below 2.00

Academic Standing Categories	Academic Standing Criteria
Warning	 Students are on academic warning if <i>any</i> of the following conditions are met: The student receives a GPA below 2.00 for their first academic period of enrollment at Mason. The student has a GPA below 2.00 for the academic period and has a cumulative GPA at 2.00 or above. The student receives a GPA below 2.00 for the academic period, has a cumulative GPA below 2.00 and has never received an academic warning. Please note: academic warning does not appear on the student's transcript.
Probation	 Students are on academic probation if <i>all</i> of the following conditions are met: The student receives a GPA below 2.00 for their first academic period of enrollment at Mason. The student has a GPA below 2.00 for the academic period and has a cumulative GPA at 2.00 or above. The student receives a GPA below 2.00 for the academic period, has a cumulative GPA below 2.00 and has never received an academic warning.
First Suspension	 Students are on academic first suspension if <i>all</i> of the following conditions are met: The student has not previously been on academic first suspension. The student has been on academic probation in any previous academic period. The student receives a GPA below 2.00 for an academic period. The student has a cumulative GPA below 2.00.
Second Suspension	 Students are on academic second suspension if <i>all</i> of the following conditions are met: The student has not previously been on academic second suspension. The student has returned from an academic first suspension. The student receives a GPA below 2.00 for the academic period. The student has a cumulative GPA below 2.00.
Dismissal	 Students are on academic dismissal if <i>all</i> of the following conditions have been met: The student has returned from academic second suspension. The student receives a GPA below 2.00 for the academic period. The student has a cumulative GPA below 2.00.
