

2020 NUMBERS AT A GLANCE

- **44,411,750:** Approximate number of immigrants living in the U.S. (14% of the population)
- **1,779,060**: Approximate number of immigrants in Illinois (14% of the state's population)
- 13th: Rank of Illinois among the 50 states and the District of Columbia in terms of immigrants as a percentage of the state's total population
- **28,250:** Approximate number of immigrants in McHenry County, Illinois (9% of the county's population)

Distribution of Immigrants

The top three counties with the highest percentage of foreign-born residents are located in northeastern Illinois and include Cook (21%), DuPage (19%), and Lake Counties (19%). Additionally, immigrants make up 9% of McHenry County's total population. These four counties are all located within the bounds of the Chicago metropolitan area, which has been an historically popular destination for international immigrants. Notably, Cook County includes the city of Chicago, which has a particularly rich history of immigration since the late 19th century. By contrast, the counties with the lowest share of immigrants are Alexander (0.27%), Gallatin (0.28%), and Greene (0.32%), which are three small counties in rural areas with few motivations for immigration.

All analysis in this fact sheet is based on source data from the U.S. Census Bureau American Community Survey, 2016-2020 distributed through IPUMS-USA, University of Minnesota, www.ipums.org, unless otherwise noted.

Please note that the terms "immigrant" and "foreign born" are used interchangeably throughout this fact sheet. Foreign born refers to individuals who are not a U.S. citizen at birth or who were born outside the U.S., Puerto Rico or other U.S. territories and whose parents are not U.S. citizens. The foreign born may include naturalized U.S. citizens, Legal Permanent Residents, temporary residents, refugees and asylees, and others. Additionally, native born includes those who are U.S. citizens at birth, those born in the United States, Puerto Rico, or other U.S. territories, and those born abroad to a parent who is a U.S. citizen.

Overall, Figure 2 shows that immigrants in McHenry County have a similar age distribution compared to all other immigrants in Illinois. The similar median age of 46 years old for immigrants in McHenry County and 45 years old for their counterparts in the rest of Illinois further demonstrates this trend. Nonetheless, Figure 2 data also shows that immigrants in McHenry County are slightly more likely to be 35 to 64 years old than all other immigrants in Illinois (62% to 56%). The fact that a greater share of immigrants in McHenry County arrived to the United States from 1930 to 1989 than all other immigrants in the state (37% to 31%) partially explains the variation in these two groups' age distributions.

Figure 3. Naturalization Rates Among Immigrants




Figure 3 shows that immigrants in McHenry County, Illinois have identical naturalization rates to all other immigrants in the state (i.e., 52% are naturalized citizens in each group), This is surprising given immigrants' higher English proficiency in McHenry County than in the rest of the state (62% to 52%). The fact that immigrants in McHenry County have similar year of immigration trends as their counterparts in the rest of Illinois may partially explain the naturalization trends displayed in Figure 3. For example, immigrants in McHenry County have 1995 as their median year of immigration to the United States compared to 1997 for all other immigrants in Illinois. Additionally, 63% of immigrants in McHenry County arrived to the United States from 1990 to 2018, compared to 69% of all other immigrants in the state.

As shown in Figure 4, immigrants in McHenry County are notably more likely to identify as white than all other immigrants in the state (63% to 45%). Compared to all other immigrants in the state, a larger share of immigrants in McHenry County are born in European countries. Poland (11%) and Germany (3%) are the second and fifth top countries of birth for immigrants in McHenry County, Illinois. By comparison, Poland (7%) is the third top country of birth for all other immigrants in Illinois and the only European nation that ranks among the top five countries of birth for this group. Immigrants in McHenry County are about as likely to identify as Hispanic as their counterparts elsewhere in the state (44% to 42%).

In the Labor Force, Ages 16-65




Figure 5 shows that immigrants in McHenry County and in the rest of Illinois are equally likely to be employed (95%). The fact that these two groups have similar occupational characteristics may partially explain this trend. For example, immigrants in McHenry County have the same top occupation (i.e., service occupations) as immigrants across the state. Specifically, 24% of immigrants in McHenry County and 21% of all other immigrants in the state work in service occupations (see Figure 6).

Figure 6. Occupation Among Immigrants



Figure 6 shows that immigrants in McHenry County and elsewhere in the state of Illinois have the same top occupation (i.e., service occupations) and are employed at similar rates in these occupations (24% to 21%). The most notable difference in Figure 6 is in the fifth top occupation listed for immigrants in McHenry County and all other immigrants in the state. Immigrants in McHenry County have healthcare practitioners and technical occupations (8%) as their fifth top occupation, while all other immigrants in the state have computer, engineering, and science occupations (9%) in fifth place.

Figure 7 shows that immigrants in McHenry County are overall more likely to have 1 or more children than all other immigrants in the state (64% to 54%). Immigrants in McHenry County are more likely to be married and have a higher household income than their counterparts in other parts of Illinois, factors which may partially explain this trend. Specifically, 67% of immigrants in the county are married compared to 61% of all other immigrants in Illinois. Furthermore, the median household income of immigrants in McHenry County is \$72,158 compared to \$64,942 for all other immigrants in the state. Overall, being married and having a higher household income could better position immigrants in McHenry County to support larger families than immigrants elsewhere in Illinois.

For factsheets that examine populations at the household level, please note that a household includes all the people who occupy a housing unit. A native-born U.S. citizen household is defined as a household which is headed by a native-born U.S. citizen, regardless of the immigration status of the spouse. Conversely, an immigrant-headed household is defined as a household which is headed by a foreign-born individual, regardless of the immigration status of the spouse. For fact sheets that examine total household income, please note that the total annual income of all members in the household is included in the analysis.
