Program Highlights

The Social Entrepreneurship concentration (SOCE) provides a theoretical and practical toolkit to engage with real-world issues in industry, nonprofits, government, public policy, and education. Underlying the social entrepreneurship program is a commitment to social justice and care for human dignity. A trait common to SOCE students is a desire to model and implement sustainable, practical, and ethical solutions to social problems, while working effectively within complex networks made up of divergent groups of stakeholders.

You will engage in internships and other co-curricular activities. Students have interned at places such as:

- Ashoka, a global network for social entrepreneurship
- Armed Services Arts Partnership, an organization reintegrating veterans through the arts
- Together We Bake, a comprehensive workforce training and personal development program

The concentration in SOCE will equip students with the subject matter expertise, strategic knowledge, technical support, and social networks needed to:

- create, operate, develop, and accelerate startups
- bring ideas to scale
- improve existing programs' effectiveness
