## **ECON 310: Money and Banking**

**Course Description:** This course will examine monetary, commercial, and central banking systems, with particular emphasis on their relationship with U.S. government programs, fiscal policies, and controls.

**Course Objectives:** By the end of the semester, students will have a broad understanding of how financial institutions affect the economy. In particular, we will study the behavior of interest rates, how banks are structured and managed, and how the Federal Reserve conducts monetary policy.
