Course Description and Objectives:

The objective of this course is to analyze the behavior of criminals who commit heinous crimes. This class will examine what factors influence violent criminals. Throughout this course students will learn the history and methods of criminal profiling, analyzing crime scenes for offender behaviors and characteristics utilizing profiling methodologies and logic reasoning. Students will study criminal profiles and equivocal death analysis from forensic and behavioral evidence.

Exams (30 points each):

The midterm and final exams will be closed book and will use a combination of multiple choice, fill-in-the-blanks, and essays. Make-up exams will only be given under exceptional, unavoidable circumstances with proper documentation. If you know in advance that you will have to miss an exam, please notify me ASAP. Taking an exam late may result in a penalty.

Criminal Profile Paper (40 points):

You are to select a serial killer or deviant criminal and explain the biological, situational and developmental factors that contributed to the criminal's behavior. Examine their crimes and provide motive, intent, MO and Signature analysis based on one or more profiling methodologies. The profile paper needs to be thorough and detailed with a comprehensive description of the subject's background (both criminal and noncriminal) including the following:

- Seek to explain the subject criminal's behavior utilizing methodologies and theories learned in class.
- Include information on the criminal's MO/Signature, the offender's motive, and intent.
- Examine victimology and provide forensic victimology if victim information is available.
- Explain other relevant consequences of the crime (e.g., public reaction, secondary victims, media/reporting, law enforcement activities; and future implications).

The paper should be 10-15 pages in length. References should be from various sources, including but not limited to textbooks, academic journals, professional journals, and web based materials.

NOTE: Wikipedia is not a valid source. All hard copy and online sources need to be properly citied in APA style within the paper and in a reference list. A full criteria will be provided in class.

The paper is due TUESDAY NOVEMBER 5th 2019. **DIGITAL COPIES ONLY** in .PDF via GMU email.
