Course Description: Students will learn and apply research methodology to psychological phenomena. This course will break down each step of the research process—starting with the definition of *science*. Understanding research methods requires familiarity with several methodological topics, including measurement, research design, and statistical analysis. Along the way, students will develop a "healthy skepticism," while actively applying what they've learned in class to their lives.

Learning Outcomes: By the end of the course, students should be able to:

- Understand why a knowledge of research methodology is a practical skill
- Integrate the Scientific Method into their everyday lives
- Identify and apply basic research design principals
- Critically evaluate psychological research
- Communicate research ideas in written form using APA guidelines

Specialized Designation: Writing Intensive in the Major.

Course Overview

This course is divided into **5** weekly modules. For each weekly module you will be required to do the following:

- 1. *Attentively* watch the online lecture(s)
- 2. Respond to the Piazza discussion
- 3. Complete weekly assignments (password to quiz will be given during online lecture)
- 4. Work on lab assignments

Given the asynchronous nature of the class, weekly assignments will **not** be accepted after the due date. *If you are having technical difficulties, these should be communicated to at least one day before the due date.* This course is designed to give you autonomy, while ensuring accountability for your course responsibilities.

- This class is taught entirely online. This course is also designated as "asynchronous" meaning that there is no appointed "class time" when everyone needs to be online together. The schedule is somewhat self-paced.
- This course is divided into weekly modules- each module will be due on *Sunday at 11:59 pm EST*. I will release materials related to that week on *Monday at 11:59 am EST*. You may complete the required components at any time prior to the module due date. Module due dates and start dates are listed in the Course Schedule.
- While the ability to have this course be self-paced allows for flexibility, it can also make it easier to procrastinate and fall behind. I highly recommend NOT waiting until right before due dates to start working on the assignments or watching the lectures.

All course materials will be stored within Google Drive; however, access to these documents will be provided through Blackboard.

Required Lectures: Each week I will release online lecture(s)—these lectures are meant to supplement your understanding. Lecture slides will be posted corresponding to each week (<u>you can see the lectures</u> <u>here</u>). **Quizzes will address material discussed in the lectures**.

Required Discussions: Each week I will post a thought question on the course's *Piazza* website. To receive credit in a given week you will need to:

- Create a follow-discussion that responds to my question
- Reply to a classmate's follow-up discussion


You can post your post and reply anonymously (I will still be able to see who posted what). I just ask that you **do not troll** one another, please see the <u>Technology Policy</u> for more information on how to behave within *Piazza*.

Additionally, at the end of the semester, I will reward 10 bonus points to 15 students that go over their 2 post requirements with interesting thoughts, follow-up points, questions, etc. This reward will be given to 3 students each week—students can only receive the award once during the class.

Required Assignments: You will be required to complete *2 weekly assignments*. These will be a combination of multiple-choice quizzes and short-answer questions. I am not an instructor that enjoys giving assessments that require memorization. Much of the assessment content will evaluate high-order thinking— so be prepared.

Note: All weekly assignments will be open-note, password protected, and timed. Passwords will be given during the lecture. Assignments will need to be completed in a single sitting, this is to prevent cheating.

Grading Policy



Weekly Assignments (40%): Each week you will have to complete 2 weekly assignments that will assess your understanding of the reading and lecture. These will be timed assignments.

Piazza Discussion (14%): Each week you will have to post an answer to a discussion question, as well as reply to a classmate's question.

Lab (40%): The laboratory section is taught separately from the lecture section of this course. However, your work through the lab accounts for 17% of your final grade in this course. Your lab instructor will provide me with your grades for lab assignments and papers.

The lab for Psychology 301 fulfills the **Writing Intensive requirement** in the psychology major that is a university requirement. It does so through a written research proposal completed in the context of the

lab sections and through other written assignments. The schedule of due dates will be on the lab syllabus. The final research proposal is mandatory. Drafts will be essential and if a student fails to turn in drafts it is unlikely the final written proposal will receive a passing grade. This written work is required for students to successfully fulfill the university writing intensive requirement. Students who fail to meet the writing intensive requirement will not receive a passing grade in Psychology 301. Please note that the above requirement is mandated by the University.

Research Participation (6%): Each student is required to complete **three** credits as a participant in psychology experiments. Alternate experiences may be substituted. You can sign up for a Sona Systems account by using this link: http://gmu.sona-systems.com/ and then clicking on the "Request an account here" link under New Participant. Each completed credit will count as 2% points added to your final grade. Given research changes due to COVID-19, I will also provide an alternative assignment in week 4 as a potential substitute for research participation.

Optional Cumulative Final Exam (40%): If you are not happy with your weekly assignment grade, you may take an optional Final Exam. The <u>Final Exam will be cumulative</u> and will include material from the text as well as material from class. If you choose to take the optional Final Exam, I will calculate your Final Grade two ways: based on the grade you aren't happy with and also based on the Final Exam. I will assign as your Final Grade the higher of the two. **Please note**: that all percentages will be truncated (you must be able the lower bound).
