Course Description and Objectives:

The objective of this course is to analyze the behaviors of criminals who commit heinous crimes – to learn how to profile criminals. This class will examine the factors that influence violent criminals, (e.g. environment, mental disorders and personality). We will examine research in the field of criminal investigative analysis. Throughout this course students will learn the history and focus on the various methodologies used to assess criminal behavior. Criminal profiling, analyzing crime scenes for offender behaviors and characteristics of deviant criminal includes utilizing social scientific theory and logical reasoning. Students will study criminal profiles and learn to create profiles from forensic and behavioral evidence. This course will also cover forensic victimology.

Required Textbook: None

Readings will be posted to Blackboard each week. Please prepare for class by reading the assigned articles and case studies. The content of the readings will also appear on the midterm & final exams.

Course Format:

Class will mainly be presented in lecture format. There will be class participation exercises as well as relevant case studies. Corresponding materials will be posted on Blackboard throughout the course, given out in hardcopy during class, or emailed to the students. Students will be profiling cases.

You will be provided a data set (case file) in which you will have to apply the methods of criminal profiling. This 2-3 page mini-profile will contain an explanation of the subject's criminal behavior utilizing techniques and theories learned in class.

Exams (Midterm 25%; Final 25%):

The midterm and final exams will be administered in class (1:30pm – 4:10pm) and will use a combination of multiple choice, fill-in-the-blanks, short answer and essay. You will be expected to create profiles based on provided data and scenarios. Make-up exams will only be given under exceptional, unavoidable circumstances with proper documentation. Criminal Profiling Research Paper (35%):

You are to select a serial killer or deviant criminal (or crime/terrorist group) and explain the psychological, emotional, biological, situational and/or developmental factors that contributed to the criminal's behavior. You will be collecting the relevant data for your research.

The paper will examine the perpetrator's crimes and the profile will include motive, intent, MO and the analysis of a signature by using a variety of criminal profiling methodologies. The profile paper needs to be thorough and detailed with a comprehensive description of the subject's background (both criminal and noncriminal) including the following:

- Seek to explain the subject criminal's behavior utilizing techniques and theories learned in class.
- Ground the profile in one or more of the methodologies discussed in class.
- Examine victimology and provide forensic victimology if victim information is available.
- Explain other relevant consequences of the crime (e.g., public reaction, secondary victims, media/reporting, law enforcement activities)

The paper should be 10-15 pages in length (not counting the cover page or reference pages). References should be from various sources, including but not limited to textbooks, academic journals, professional journals, and web based materials.

<u>NOTE</u>: Wikipedia is not a valid source. Docu-dramas or other written/video sources that are not authored by credible sources or law enforcement professionals are not considered valid sources. All hard copy and online sources need to be properly citied in APA style.

Paper Due Date: Wednesday, November 8th (upload to Blackboard by midnight)

IMPORTANT NOTE: Assignments and exams are due on the dates provided. A full grade penalty will be issued for any late assignment.

<u>IMPORTANT NOTE</u>: I do not "round-up" final grades. In order to be fair to everyone, I use the grade scale consistently. So if you end up with an 89.2 – that is a B+. I use the base number, not the decimal points as the determining factor for final grades.

<u>IMPORTANT NOTE</u>: While Blackboard will be used to turn in assignments, you will need to keep track of your grades during the semester. I do not post or return grades via Blackboard.
